

It is stressed that this course is NOT a recitation of legal requirements, but a practical guide to those officials required to deal with open records requests. He was formerly the Chief of Legal Services for the Texas Department of Public Safety. Prior to his appointment as Chief, Mr. West served as General Counsel and Assistant General Counsel for D.P.S. Mr. West has been involved with Public Information Act since it was passed in 1973. Mr. West was licensed to practice law in 1969.

Because of the increasing complexity of the Texas Public Information Act and to provide adequate time for proper explanation of the most recent changes, this course has been lengthened from eight to twelve hours.
